#### **SECTION 4: First aid measures**

#### 4.1. Description of first aid measures

General information Get medical attention if any discomfort continues. Show this Safety Data Sheet to the medical

**Inhalation** Move affected person to fresh air and keep warm and at rest in a position comfortable for

## Protective actions during firefighting

Alternatively, or if it is not water-soluble, absorb the spillage with an inert, dry material and place it in a suitable waste disposal container.
